If I am injured while residing at and participating in programs at the Virginia Hunter Skills Weekend of any auxiliary facility: (1) I and my family agree to waive any legal claim against the Department of Wildlife Resources and/or Holiday Lake 4-H Educational Center and/or the Virginia Hunter Education Association and those associated with the above mentioned organizations; (2) I give consent for the Department of Wildlife Resources to provide medical/athletic training attentions, transportation and emergency medical services as warranted.

If injured while traveling to or from the Virginia Hunter Skills Weekend by public, private or any other means of conveyance, I agree to waive any legal claims against the Department of Wildlife Resources and/or the Holiday Lake 4-H Educational Center and/or the Virginia Hunter Education Association. By signing this release, I swear that I am in such physical condition that participation in this program will not result in my being injured; also, I know of no injury or disease that would result in my being injured during any program participation. If I am less than 18 years of age, A parent or guardian shall sign this release with me.

Code of Conduct

1. Participants should attend and be actively involved in all scheduled activities as part of this program/event. Some areas are off-limits to participants (ex: swimming pool; bodies of water such as lakes and rivers; challenge course, etc.) unless during scheduled activity times.
2. Participants are expected to follow the directions of volunteers and paid staff.
3. Participants should respect the property of others and be responsible for themselves. Deliberate destruction or removal of facilities or equipment is not permitted. Financial responsibility for any damages caused by deliberate destruction will be assumed by the participant and/or parents/guardians. The same applies to the property and personal items of other participants.
4. Participants should treat all others and themselves with respect. Aggressive, abusive, vulgar, or violent language and behavior towards others (ex: fighting, threats, insults, cursing, discrimination, etc.) are not permitted.
5. Participants should respect the privacy of others.
6. Possession, distribution, or use of alcoholic beverages, illegal drugs, tobacco products, and unauthorized prescription drugs are not allowed at any program/event and must be reported to law enforcement.

Consequences

Unacceptable behavior during this program/event (as defined within this Code of Conduct) will result in consequences to the participant. Consequences may include:

1. early release from this program/event without refund,
2. restitution or repayment of damages,
3. denial of future participation in this program/event for one or more years (as determined by the staff in charge of, or responsible for, the program/event),

NOTE: Any conduct not specifically covered by this Code of Conduct, but deemed inappropriate by those responsible for this program/event will be viewed as a violation and appropriate action will be taken. If an infraction occurs, the person in charge of the program/event will provide appropriate communication to parents/guardians.

PUBLICITY/PRIVACY RELEASE

For good and valuable consideration, the receipt of which is hereby acknowledged, the individual named or identified below ("Subject") hereby gives the Virginia Department of Game and Inland Fisheries ("VDWR") and Holiday Lake 4-H Educational Center, their directors, officers, employees and agents the absolute and irrevocable right and permission, with respect to the photographs and/or film or tape that it has taken of Subject on the date hereof:

(a) To use, re-use, publish, re-publish, reproduce, adapt, distribute and publicly perform or display Subject's name, voice, appearance or visual likeness, individually or together with others, in any form now known or later developed, including but not limited to a part of a video recording or photograph (the "Work"). Subject warrants that he/she is of legal age and has read this release in its entirety and understands the contents thereof. In the event that Subject is a minor, the signatory named below ("Guardian") warrants that he/she has full authority to grant the rights identified herein as the parent or guardian of Subject. Guardian agrees to fully indemnify and hold harmless VDWR, its officers, directors, employees and agents from any claim relating to VDWR's use of this minor's name, voice, appearance or visual likeness, should Guardian not have full authority to consent to this release.

Subject, or in the event that Subject is a minor, Guardian, hereby waives, and releases VDWR, its directors, officers, employees and agents, from liability for any claim that Subject or Guardian may have based on the so-called rights of privacy, publicity, defamation, copyright or trademark infringement, moral rights or any other right that may arise based on VDWR's use, adaptation, reproduction, publication, distribution or exhibition of Subject's name, voice, image, likeness or appearance as a part of the Work, whether such claim is now known or suspected or discovered in the future.

This Release is governed by the laws of the Commonwealth of Virginia, and this document constitutes our entire understanding upon which the parties may rely. There are no oral or other written terms, conditions or other parts of this Release or any other agreements relating thereto.
